

**Wall to Wall Diving**  
**Liability Release and Express Assumption of Risk**

**Please read carefully, fill in all blanks and initial each paragraph before signing.**

I, \_\_\_\_\_, hereby affirm that I am a certified diver and I am totally aware of the inherent risks of skin diving and scuba diving.

\_\_\_\_\_ Further, I understand that diving with compressed air involves certain inherent risks; recompression sickness, embolism or other hyperbaric injuries can occur that require treatment in a decompression chamber. I further understand that the open-water diving trips may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber. I still choose to proceed with such dives in spite of the possible absence of a recompression chamber in proximity to the dive site.

\_\_\_\_\_ I understand and agree that neither **Wall to Wall Diving** nor any of their respective employees, officers, agents or assigns (hereinafter referred to as "*Released Parties*") may be held liable or responsible in any way from any injury, death or other damages to me or my family, heirs or assigns that may occur as a result of my participation in diving or as a result of the negligence of any party, including the *Released Parties*, whether passive or active.

\_\_\_\_\_ I hereby personally assume all risks in connection with scuba diving, for any harm, injury or damage that may befall me including all risks connected therewith, whether foreseen or unforeseen.

\_\_\_\_\_ I further save and hold harmless said *Released Parties* from any claim or lawsuit be me, my family, estate, heirs or assigns arising out of my enrollment and participation in scuba diving including both claims arising during the course or after I receive my certification.

\_\_\_\_\_ I also understand that skin diving and scuba diving are physically strenuous activities and that I will be exerting myself during diving, and that if I am injured as a result of heart attack, panic, hyperventilation etc., that I expressly assume the risk of said injuries and that I will not hold the *Released Parties* responsible for the same.

\_\_\_\_\_ I further state that I am of lawful age and legally competent to sign this liability release or that i have acquired the written consent of my parent or guardian.

\_\_\_\_\_ I understand the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act.

It is the intention of \_\_\_\_\_ by this instrument to exempt and release **Wall to Wall Diving** and all related entities as defined above, from all liability or responsibility whatsoever for personal injury, property damage or wrongful death however caused including, but not limited to the negligence of the *Released Parties*, whether passive or active.

I have fully informed myself of the contents of this liability release and express assumption of risk by reading it before I signed it on behalf of myself and my heirs.
